ARTICLES OF INCORPORATION
OF
TAJAO CARPENTRY CORPORATION

ARTICLE I - NAME

The name of this Corporation is TAJAO CARPENTRY CORPORATION

ARTICLE II - DURATION

This Corporation shall have perpetual existence commencing
on July 25, 2001.


ARTICLE X - INCORPORATOR


