ARTICLES OF INCORPORATION**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I**

The name of the corporation is and shall be **CENTURY RECORDS, INCORPORATED.**

**ARTICLE II**

The principle place of business and mailing address of the Corporation is and shall be **6501 ARLINGTON EXPRESSWAY, SUITE B-208, JACKSONVILLE, FLORIDA 32211.**

**ARTICLE III**

The corporation is and shall be authorized to engage in any business lawful under Florida law.

**ARTICLE IV**

The maximum number of shares of stock that the Corporation is and shall be authorized to issue is **ONE THOUSAND** (1,000), having no par value at the time of incorporation. Such stock shall be of the common variety and shall be entitled to vote upon all matters normally voted on by stock. The corporation shall adopt, ratify, or otherwise honor any and all written pre-incorporation contracts or agreements made and executed by the undersigned incorporator including, but not limited to, stock subscriptions and offerings.

No holder, owner, keeper, or trustee of any of the stock of the corporation shall sell, give, assign, bequeath, or devise any of such stock without having first made a written offer of the stock to the corporation for purchase at its fair and reasonable value. Such written offer shall be valid for no less than thirty (30) days after its delivery to the corporation.

**ARTICLE V**

This corporation shall exist perpetually unless dissolved in a manner according to Florida Law.

**ARTICLE VI**

These **ARTICLES OF INCORPORATION** may, from time to time, be amended, altered, changed, or replaced by Resolution approved by a unanimous vote of the stock entitled to vote thereon.

Any and all compensation to officers, directors, employees, agents, or other persons employed or engaged by the corporation shall be determined by a vote of not less than ninety (90) *per cent* of the stock entitled to vote thereon.

## ARTICLE VIII

The corporation shall be governed by a Board of Directors numbering no less than two (2), which number may be changed from time to time by a majority vote of the stock. Until such time as the stock may practically meet to elect a Board of Directors, the initial Board of Directors is and shall be:

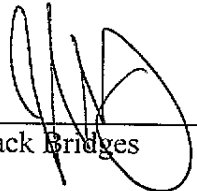
