ARTICLES OF INCORPORATION OF FOUNTAINHEAD ANESTHESIA, P.A.

Pursuant to the Florida Business Corporation Act, the undersigned incorporator of Fountainhead Anesthesia, P.A., a Florida professional corporation (the "Corporation"), hereby adopts the following Articles of Incorporation for the Corporation:

ARTICLE I NAME AND ADDRESS

The name of the Corporation is Fountainhead Anesthesia, P.A. The Corporation's principal office and mailing address is 2307 S. Hesperides St., Tampa, Florida 33629.

ARTICLE II BUSINESS AND ACTIVITIES

The general nature of the business to be transacted by the Corporation shall be as follows:

- (a) To engage solely and specifically in the business of carrying on the general practice of medicine and the specific practice of anesthesia and pain management; and
