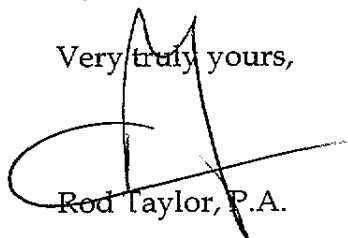

ARTICLE I – Name and Principal Place of Business

The name of this corporation is SAFARI GOGOLF TOURS, INC., and its principal place of business is 6600 Mission Club Blvd., Number 307, Orlando, FL 32821.

ARTICLE II – Purpose
