ARTICLES OF INCORPORATION


BY THESE ARTICLES OF INCORPORATION the incorporator forms a Corporation for profit under Florida Law.

ARTICLE I

The name and address of the Corporation are:

BOCA VIDEO WATCH, INC. 469 NE 35th Street

Boca Raton, Florida 33431



ARTICLE II

This Corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is the date of which these Articles of Incorporation are filed with the Secretary of the State of Florida.

Such indemnification shall include, but not be limited to, the expenses, including the cost of any judgment, fines, settlements and counsel's fees, actually and necessarily paid or incurred in connection with any action, suit or proceedings, whether civil, criminal, administrative or investigative, and any appeals thereof, to which any such person or his legal representative may be made a party or may be threatened to be made a party by reason of his being or having been a director, officer, employee or agent as herein provided. The foregoing right of indemnification shall not be exclusive of any other rights to which any directors, officers, employees or agents may be entitled as a matter of law or which they may be lawfully granted.
