ARTICLES OF INCORPORATION

OF

SCORING AMILION BLACK & WHITE PHOTO IMPRESSIONS BY MICKIE INC.

(a Florida Corporation)

The undersigned, acting as incorporator Black & White Photo Impressions By Mickie Incorporated, proceeds to form a corporation under the Florida General Corporation Act, and adopts the following Articles of Incorporation:

ARTICLE I. CORPORATE NAME

The name of this corporation is Black & White Photo Impressions By Mickie Incorporated.

ARTICLE II. STREET AND MAILING ADRESS OF PRINCIPAL OFFICE

- 1. 3. No shareholder of the Corporation shall enter into a voting trust or any other type of agreement vesting another person with the authority to exercise the voting power of any or all of his or her shares.
