1. Name. The name of the corporation is JOHN NUCE ACOUSTIC CEILINGS INC. (the "Corporation").

- 2. Articles of Incorporation. The date of filing of the Articles of Organization of the Corporation was August 2, 2001 with an effective date of August 1, 2001 (Document Number P01000076025).
- 3. <u>Amendment.</u> The Articles of Incorporation of the Corporation are hereby amended as follows:

Article 1 is deleted and a new Article 1 is inserted in lieu thereof, to read as follows:

4. Adoption of Amendment. Pursuant to Section 607,1006 of the Florida Business Corporation Act, JOHN NUCE ACOUSTIC CEILINGS, INC. adopts these Articles of Amendment. The foregoing amendment to Article 1 was adopted and approved by the sole Director and sole Shareholder of the Corporation by joint written consent without a meeting, effective on November 25, 2009. The written consent was sufficient for approval by the sole Director and sole Shareholder.
