ARTICLE I

NAME

The name of this Corporation is **ECONO PRINTING, Inc.**

The foregoing right of indemnification shall not be exclusive of any other right to which any Director, Officer, Employee or Agent may be entitled as a matter of law or which he may be lawfully granted.

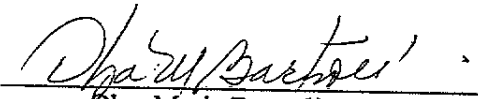
