ARTICLES OF DISSOLUTION


Sikandar, Inc. wishes to voluntarily dissolve.

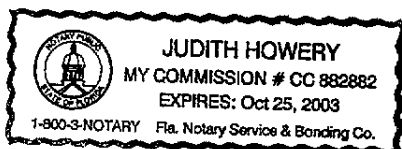
