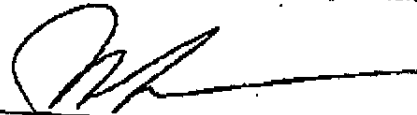
ARTICLE IX - INITIAL OFFICERS

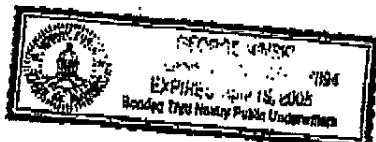

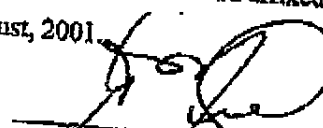
