## ARTICLES OF AMENDMENT TO

ARTICLES OF INCORPORATION

OF

FALLARY OF STATE

FERIA INTERNACIONAL DE ARTE CONTEMPORANEO DEL CARIBE, HNSEE, FLORIDA

We the undersigned, being the President and Secretary of Feria Internacional De Arte Contemporaneo Del Caribe, Inc., a Florida corporation, hereby certify that the following amendment to the Articles of Incorporation was duly adopted by the Voting Members and by the Board of Directors of the Corporation at a meetings duly held by them on November 12, 2001.

## AMENDMENT

1. Name of Corporation. The present name of the Corporation is "Feria Internacional De Arte Contemporaneo Del Caribe, Inc." The name of the Corporation hereby changed to "Puerto Rico Art Fair, Inc." Article I (Puerto Rico Art Fair, Inc.) of the Articles of Incorporation is amended to read as follows:

## ARTICLE I. NAME

The name of the Corporation is: Puerto Rico Art Fair, Inc.

- 2. This Amendment was approved by a majority of the Corporation Common Stock, which is the only group of the corporation shareholders entitled to vote on the Amendment, and the number of votes in favor of the Amendment was sufficient for approval.
- 3. In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.
