ARTICLES OF CORRECTION

FOR

SAFETY ENVIRONMENTAL ASSESSMENT SYSTEMS, INC.

Pursuant to the requirements of Section 607.0142, Florida Statutes, the undersigned does hereby make, swear to, adopt and file these Articles of Correction for Safety and Environmental Assessment Systems, Inc. (the "Corporation"), which Corporation was incorporated under the laws of the State of Florida on August 3, 2001:

1. The undersigned, as sole Incorporator of the Corporation, filed Articles of Incorporation on August 3, 2001.

2. Article I, Name and Duration, of the Articles of Incorporation incorrectly stated that the name of the Corporation is "Safety Environmental Assessment Systems, Inc." The correct name of the Corporation is "Safety and Environmental Assessment Systems, Inc." Therefore, the Corporation hereby amends Article I, Name and Duration, of the Articles of Incorporation to read as follows:

"The name of the Corporation is Safety and Environmental Assessment Systems, Inc. The duration of the Corporation is perpetual. The effective date upon which this Corporation shall come into existence shall be the date these Articles are filed by the Secretary of State."

3. All other provisions of the Corporation's Articles of Incorporation shall remain in full force and effect, unaltered except as expressly provided above.

4. The foregoing Articles of Correction were adopted by the sole Incorporator of the Corporation on the 6th day of August, 2001, effective as of August 3, 2001.
