ARTICLE I - NAME

The name of this Corporation is AM Web Pages, Inc.

ARTICLE II - ADDRESS

The principal office and the mailing address of this Corporation is 2017 Cardiff Lane, Middleburg, FL 32068.

ARTICLE III - CAPITAL STOCK

(a) Authorized Shares. This Corporation is authorized to issue 500 shares of common stock, all of which shall be of the par value of \$.01 per share. Each of the shares of common stock shall entitle the holder thereof to one (1) vote at any meeting of the shareholders. (d) Restrictions on Transfer of Stock. The shareholders may, by bylaw provision or by shareholders' agreement recorded in the minute book, impose such restrictions on the sale, transfer, or encumbrance of the stock of this Corporation as they may see fit.
