The undersigned incorporator, for the purpose of forming a corporation for profit inderthe Florida Business Corporation Act, hereby adopts the following Articles of Incorporation

ARTICLE I

The name of the corporation is SIGNATURE TITLE SERVICES, INC. (The "Corporation").
