

**ARTICLES OF INCORPORATION
OF
ALAMAR IRRIGATION, INC.**

I, the undersigned Incorporator, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is:

The Principle place of business of this corporation shall be 3316 Ohio Avenue, Sanford, Florida 32773.

ARTICLE II


ARTICLE X



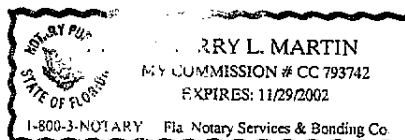


