ARTICLE I-Name

The name of this corporation is Lewis Chiropractic, P.A.

ARTICLE II- Principal Office

The address of the principal office and mailing address is 210 West Center Avenue, Sebring, Florida 33870.

ARTICLE III-Duration

This corporation shall have perpetual existence.

ARTICLE IV-Purpose

This corporation is organized for the purpose of engaging in the business of chiropractic medicine and related professional services for which the shareholder(s) shall be licensed to render.

ARTICLE V-Capital Stock

This corporation is authorized to issue Eight Thousand (8,000) shares of One Dollar (\$1.00) par value common stock which shall be designated "Common Shares".

ARTICLE VI-Preemptive Rights

ARTICLE VIII-Initial Board of Directors
