-- Dear Department of State, --

I am writing this letter to address a serious situation on the behalf of my corporation. I have recently discovered a situation that is beyond my control. I have no recourse other than to "attempt with full honesty and earnest effort to correct the situation". I am asking for an abatement of traditional penalties and interest in this extreme case. I have been incorporated since 7/29/01 and have to the best of my ability complied with the Florida and Federal filing requirements.

The purpose of this letter is to explain this unfortunate situation and plead for some sort of understanding and fairness. Here we go:

In late 2001, my business partner, Tim Feight, passed away. Mr. Feight's address was used as the Corporation's address of record. I properly filed change of address forms and filed a forwarding address requests. However, I did have some problems with my mail route. I also had issues with my former partner's landlord in regards to forwarding some of my mail. I tried to the best of my ability to resolve these issues. However, there were some problems accounting for all of my mail. In the move, I made sure to address all filing requirements for which I received correspondence.

It came to my attention on December 4, 2002 that there was a problem with my Corporation when I went to renew some of my business contracts with a vendor. The vendor made me aware of that my corporation had been "ADMIN DISSOLUTION FOR ANNUAL REPORT". As soon as I realized this, I researched the issue. I researched my account history on the website after speaking with someone at the Division of Corporations. I soon discovered that the mailing address of record on the website (1115 Ponce De Leon Box 31, Belleair, FL 33756) was my former partner's address. Thus, the annual corporate reports must have been mailed to that address and NEVER forwarded to me new address. I did not receive ANY of the notices sent by your office. I am writing to ask for some understanding on this issue

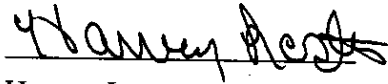

Please give me an opportunity to resolve this issue fairly and move on. I respect your understanding in this unforeseen incident.
