**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is Intensive Resources International, Inc.

ARTICLE II - ADDRESS

The principal office and the mailing address of this Corporation is 1555 The Greens Way, Jacksonville Beach, Florida 32250.

ARTICLE III - CAPITAL STOCK

(a) Authorized Shares. This Corporation is authorized to issue 2,000,000 shares of common stock, all of which shall be of the par value of \$.01 per share. Each of the shares of common stock shall entitle the holder thereof to one (1) vote at any meeting of the shareholders. All or any part of the common stock may be paid for at a fair valuation to be fixed by the Board of Directors at a meeting called for such purpose. All stock when issued shall be fully paid and nonassessable.

(b) Preemptive Rights. Shareholders shall have no preemptive rights.

(c) Cumulative Voting. Cumulative voting shall not be permitted.

(d) Restrictions on Transfer of Stock. The shareholders may, by bylaw provision or by shareholders' agreement recorded in the minute book, impose such restrictions on the sale, transfer, or encumbrance of the stock of this Corporation as they may see fit.
