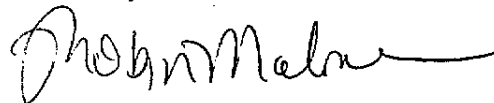

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this Corporation is Oceanview Systems, Inc.

ARTICLE II - DURATION

This corporation shall exist into perpetuity unless sooner dissolved by law.

ARTICLE III - PURPOSE

The purposes for which this corporation is formed are:. providing services, products and consultation relating to sales, utilization, maintenance and repair of computers, computer systems and all other related business without limitations.

ARTICLE IV - CAPITOL STOCK

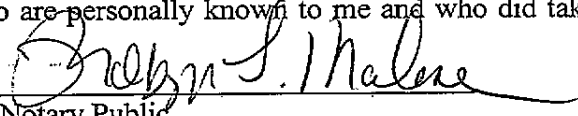

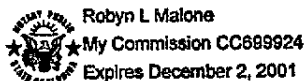
