

**ARTICLE I. CORPORATE NAME**

The name of this Corporation is Euphorium, Inc..


## **ARTICLE XI. PRE-EMPTIVE RIGHTS**

## **ARTICLE XII. INDEMNIFICATION**


This Corporation shall indemnify any officer or director or any former officer or director, to full extent permitted by law.
