<u>Precomptive Rights</u> The corporation elects to have precomptive rights so that each areholder has the right to acquire a proportional amount of any shares that are issued.

Director or Officer Interest. In the absence officed, no transaction between (a) this corporation and (b) any other association, corporation or any director or officer of this corporation individually, shall be affected by the fact that any director or officer of this corporation individually a party to the transaction or is interested in or is a director or officer of such other association or corporation

Stock Transfer Restriction No shareholder of this corporation shall sell any shares of stock he by him or her in this corporation without first offering to sell such stock to the corporation on same terms and conditions and at the price offered in good faith and in writing, by any proposed purchaser. The writtenoffer by such proposed purchaser shall be delivered to the corporation the time the stock is offered to the corporation for sale. The corporation shall have the right accept the offer any time within thirty (30) days from and after the date on which the offermade to the shareholder and shall exercise the option to purchase by notifying the shareholder writing. If the corporation shall not exercise its option to purchase the shares of stock, it should notify the shareholder in writing within the thirty (30) day period and the shares may then be seen by the shareholder, but only to the proposed purchaser on the same terms and conditions are offered to the corporation, and only within thirty (30) days from and after the date on which the corporation declines to exercise its option.
