


Article IX - By-Laws



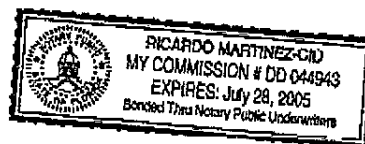


