ARTICLE X, AMENDMENT



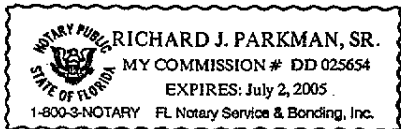
