Pursuant to the provisions of Section 607 of the Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation:

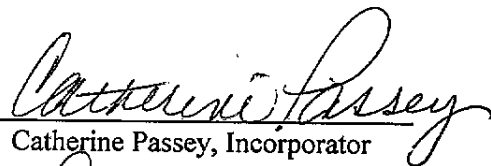
1. The name of the corporation is D.C. MANPOWER, INC.
2. The following amendment to the articles of incorporation was adopted and approved by the incorporators on August 9, 2001. No shareholder vote is/was required for this name change Amendment.

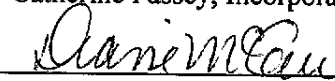
Article I of the original articles of incorporation shall be deleted and replaced with the following:
