ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF WISHNATZKI, INC.

Wishnatzki, Inc., a Florida corporation organized and existing under the laws of the State of Florida (the "Corporation") hereby certifies as follows:

- Name of the Corporation. The name of the Corporation is Wishnatzki, Inc. 1.
- Date of Filing of Articles of Incorporation. The Corporation filed Articles of 2. Incorporation on August 7, 2001 (the "Articles") with the Florida Department of State.
- Amendment to Articles. The undersigned desires to amend the Corporation's Articles, and the Articles are hereby amended, by deleting the current Article I in its entirety and inserting the following in its place:

"ARTICLE I Name and Address
