ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

ARTICLE I Name O7 30 01

Section 1.1. Name. The name of the corporation is Gabriel Brothers Co.

ARTICLE II Duration

Section 2.1. <u>Duration</u>. This corporation shall exist perpetually.
