The undersigned incorporator to these Articles of Incorporation, a natural person competent to contract and a medical doctor duly licensed to render services as such under the laws of the State of Florida, hereby forms a Professional Corporation for profit pursuant to the provisions of the Professional Service Corporation Act and other laws of the State of Florida.

ARTICLE I. <u>CORPORATE NAME</u>.

The name of this corporation shall be:

ARTICLE II. PRINCIPAL OFFICE.

The initial principal office of the corporation shall be:

ARTICLE III. PURPOSE.

C. To conduct and transact any business lawfully authorized and not prohibited by Chapter 621, Florida Statutes, as the same may be amended from time to time.
