ARTICLE I
Name

The name of this corporation is RAMESH SALES & SERVICES, INC.

ARTICLE II
Duration

This corporation shall have perpetual existence.



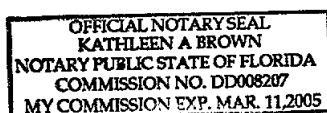
