ARTICLES OF INCORPORATION OF

Rainbow Pool Cleaning & Supplies, Inc.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE 1. NAME

The name of the corporation shall be: Rainbow Pool Cleaning & Supplies, Inc..
