#### ARTICLE I

# Name and Mailing Address

#### Existence of Corporation

This corporation shall begin existence on August 8, 2001, and shall have perpetual existence.

#### **Purposes**

This corporation may engage in the transaction of any or all lawful business for which corporations may be incorporated under the laws of the State of Florida.

#### **Powers**
