**ARTICLES OF INCORPORATION**

**OF**

**ANDREW D. HENRY, MD., P.A.**

**A PROFESSIONAL CORPORATION**

The undersigned, whom is duly licensed to engage in the practice of Internal Medicine / Endocrinology within the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I - CORPORATE NAME**

The name of the corporation is:

**ARTICLE II - DURATION**

This corporation shall exist perpetually unless dissolved according to Florida Law.

**ARTICLE III - PURPOSE**

The purpose for which the corporation is organized shall be to engage in the practice of Internal Medicine / Endocrinology within the State of Florida, and to take all actions that are necessary or proper in connection with that practice.

The professional services of the Corporation shall be rendered only through officers, employees, and agents who are duly licensed or otherwise legally authorized to practice Internal Medicine / Endocrinology within the State of Florida. Professional services shall be rendered in each case by the officer, employee, or agent designated solely by this Corporation, acting through its duly elected officers. This provision shall not be applicable to the extent it is in conflict with the law or the professional rule of the profession.

The corporation is authorized to issue 1,000 Shares (Common) of ONE Dollar(s) (\$1.00) par value Common Stock, which shall be designated "Common Shares."





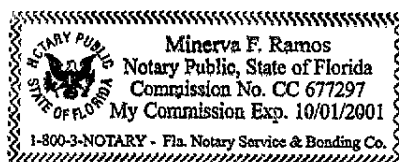
