I am founder and CEO of Creative Resolutions, Inc. I filed a timely Uniform Business Report for my company in 2002. A copy of that report is enclosed for your information.

In June of this year I received notice from my corporate lawyer that my 2003 report had not been filed. The attorney's assistant forwarded me a 2003 report and informed me that because the report was late I would have to pay a penalty. I informed her that I had never received notice that a report was due.
