**ARTICLES OF INCORPORATION
OF
WC PALMETTO PARK, INC.**

The undersigned, acting as the Incorporator of a corporation (the "Corporation" under the laws of the State of Florida as contained in the "Florida Business Corporation Act", Chapter 607 of the Florida Statutes, as amended, does hereby adopt the following Articles of Incorporation for the Corporation:

1. The name of the Corporation is WC Palmetto Park, Inc.
2. The initial mailing address of the Corporation is 1840 N. Commerce Parkway, Suite 3, Weston, Florida 33326.
3. The Corporation shall have perpetual existence.
4. The aggregate number of shares which the Corporation shall have authority to issue is One Thousand (1,000) shares of common stock having a par value of One Dollar (\$1.00), all of one class.


