**ARTICLE I - NAME**


## ARTICLE IX

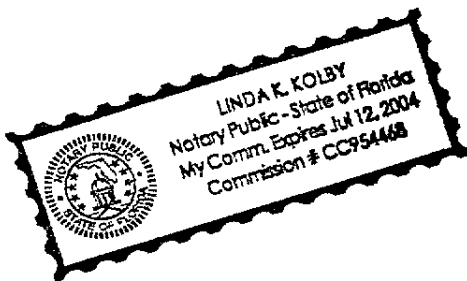


