OF

The Bylaws of this Corporation may be adopted, altered, amended or repealed by either the Shareholders or Directors/Officers.

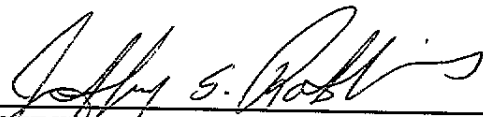
ARTICLE VIII - INCORPORATOR
