ARTICLES OF INCORPORATION

OF

J. C. PRESSURE CLEANING, INC.



The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of the corporation shall be J. C. PRESSURE CLEANING, INC.

ARTICLE II

The address of the initial office of this corporation is 5659 Native Dancer Road, Palm Beach Gardens, Florida 33418.

ARTICLE III

The general nature of the business to be transacted by this corporation shall be to engage in any activity or business permitted under the laws of the United States and the State of Florida, and to have and exercise any and all other powers conferred by the Laws of Florida upon corporations formed in the State of Florida.

ARTICLE IV

The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any one time is 5,000.00 shares of common stock having ten cents (.l0) par value per share.

ARTICLE V

The amount of capital with which this corporation shall begin business is not less than Five Hundred Dollars (\$500.00).

This corporation shall exist perpetually unless dissolved according to law.

ARTICLE VIII

The initial number of directors of the corporation shall be I (one). The number of directors may be increased or diminished from time to time by by-laws adopted by the stockholder and authorized by law.

In case one or more vacancies shall occur in the Board of Directors by reason of death, resignation or otherwise, the remaining director shall elect a successor or successors to serve for the unexpired term of the director or directors, the absence of which created such vacancy or vacancies.
