This is to certify that the undersigned does hereby establish a corporation under and by virtue of the provisions of Chapter 607, Title XXXVI, Florida Statutes and acts amendatory thereof, for the purposes and under the corporation hereinafter mentioned, and to that end, does, by these Articles of Incorporation, set forth the following:

**ARTICLE I**

The name of the corporation is TECO OF KEY WEST, INC.

**ARTICLE II**

The address of the initial registered offices of the corporation shall be 1800 Atlantic Boulevard, Unit 214-A, Key West, Florida 33040 and the name of the initial registered agent for the corporation shall be B. Terri Greene, a resident of the State of Florida.

**ARTICLE III**

The mailing address of the corporation is 1800 Atlantic Boulevard, Unit 214-A, Key West, Florida 33040 and the principal office address of the corporation is 1800 Atlantic Boulevard, Unit 214-A, Key West, FL 33040.

#### **ARTICLE IV**

The nature of the business and the objects and purpose or purposes to be transacted, promoted, or carried on by the corporation are to engage in any lawful act or activity for which corporations may be organized under the laws of the State of Florida. 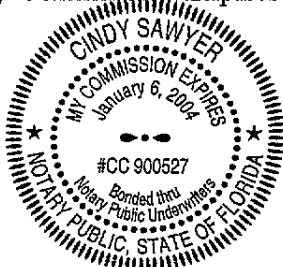
