This corporation is to exist perpetually.

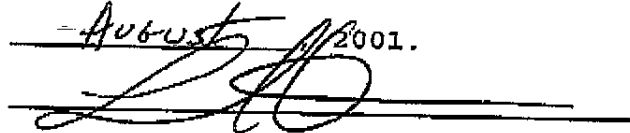

ARTICLE VII - COMMENCEMENT OF CORPORATE EXISTENCE

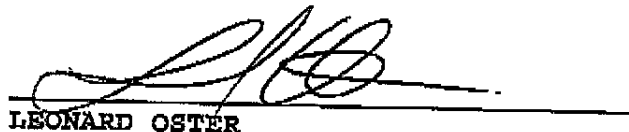
