## ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under/the Florida. Seneral Corporation Act, adopts the following Articles of Incorporation for such Corporation:

- 1. The name of the Corporation is: 321 Blastoff Online, Inc.
- 2. The mailing address for the Corporation shall be: 145B West Volusia Lane, Cocoa Beach, FL 32931.
  - 3. The period of its duration is perpetual.
