ARTICLE 1

NAME

The name of this corporation is: ROMAN YURKIEWICZ, ARCHITECT, P.A.

ARTICLE 2

DURATION

The duration of this corporation is perpetual. The date and time of commencement of the corporate existence is the time of filing of the Articles of Incorporation by the Department of State of the State of Florida.

<u>ARTICLE 3</u> PURPOSES

VOTING TRUSTS

No shareholder of this corporation shall enter into a voting trust agreement or any other type of agreement vesting in another person the authority to exercise the voting power of any or all of his shares.

ARTICLE 11

STOCKHOLDERS

Shares of this corporation's capital stock shall be issued only to individuals who are duly licensed to render services as an architect under the laws of the State of Florida, or to professional corporations or professional limited liability companies legally authorized under the laws of the State of Florida to render professional architectural services.
