THE UNDERSIGNED, ACTING AS INCORPORATOR OF A CORPORATION UNDER THE FLORIDA BUSINESS CORPORATION ACT, ADOPTS THE FOLLOWING ARTICLES OF INCORPORATION:

FIRST: The name of the corporation is Pagestream Corporation.

SECOND: The period of its duration is perpetual.

THIRD: The date and time of the commencement of the corporate existence shall be the date of the filing of these Articles by the Department of State.

FOURTH: The purpose or purposes for which the corporation is organized is to engage in the transaction of any or all lawful business for which the corporation may be incorporated under the provisions of the Florida Business Corporation Act.

FIFTH: The aggregate number of shares which the corporation shall have authority to issue is TEN MILLION (10,000,000) SHARES of COMMON capital stock, \$.001 par value each and FIVE MILLION (5,000,000) SHARES of PREFERRED capital stock, \$.01 par value each. Common stock only shall vote, and shall receive all distributions of assets in liquidation. Preferred shares are not convertible nor shall the Corporation or the holders of said shares be entitled to demand redemption, but holders shall be entitled to receive distributions of 10% (ten percent) of gross pre-tax profits per share each fiscal year, and any deficiencies shall accumulate and be paid first in subsequent years before any distribution may be made to holders of common shares.


