

ARTICLES OF INCORPORATION

OF

THE UNDERSIGNED, incorporator for the above named corporation, being a natural person competent to contract, hereby associate for the purpose of forming a corporation under the Laws of the State of Florida.

ARTICLE ONE-NAME

The name of this corporation shall be:

ARTICLE TWO-DURATION

DURATION: The corporation shall commence corporate existence on the date of the execution of these Articles of Incorporation and continue in perpetual existence unless sooner dissolved as provided by law.

ARTICLE THREE-PURPOSE

The purpose of the corporation shall be to such extent as a corporation organized under the laws of the State of Florida may now or hereafter lawfully do, either as principal or agent and either alone or in connection with other corporations, firms, or individuals, all and everything necessary, suitable, convenient, or proper for, or in connection with, or incident to, the accomplishment of any of the purposes or the attainment of any one or more of the objects of the corporation, or designed directly or indirectly to promote the interests of this Corporation or to enhance the value of its properties; and in general to do any and

all things and exercise any and all powers, rights, and privileges which a corporation may now or hereafter be organized to do or to exercise under the laws governing corporations of this state or under any amendment or replacement act, or to otherwise engage in any lawful activity either within or without the state of Florida. The corporation may buy, sell, lease, rent, encumber, deal in or otherwise dispose of real or personal property, provide any service, or otherwise engage in any lawful business activity without limitation. The Corporation may do any and all other acts and things as are necessary or convenient to the attainment of the purposes of this Corporation, to the same extent as natural persons lawfully might or could do in any part of the world, insofar as such acts are permitted to be done by a corporation organized under the Corporation Law of this state.
