

I am the owner & President of Sunbelt Investigations, Inc. A-2100232 I am in receipt of the Uniform Business Report which I understand is already past due. In October of 2001 I had made arrangements to place my firm on inactive status as I was called to active duty with the US Army for this war on terrorism.
