**ARTICLES OF INCORPORATION
OF
PO SOUL INC.**

In compliance with the requirements of F. S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the corporation ("Corporation") is **PO SOUL INC.**

ARTICLE II

The existence of the corporation shall begin on August 20, 2001.

ARTICLE III

The street address of the principal office of the Corporation is 21005 N.W. 32nd Court, Miami, Florida, 33056.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100, all of which shall be Common shares.
