
The registered office shall be at 1717 N. Bayshore Dr. Suite 213, Miami, Fl. 33132, and the registered agent being Ana Milena Perez.

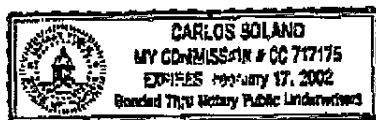
