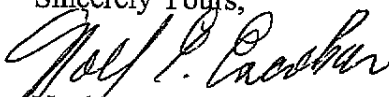

He will serve as CEO, Director, President and Treasurer.

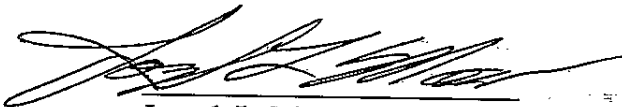
Joseph L. Mascaro 50 % ownership with 250 shares to be issued
