The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation.

**ARTICLE I.**

The name of the corporation is O & M Pools and Construction, Inc..

**ARTICLE II.**

The general character of the business to be transacted by this corporation is:

1. To transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act.
2. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

**ARTICLE III.**

The maximum number of shares of stock that this corporation is authorized to have outstanding at any time is one thousand (1,000) of common stock, each share having the par value of \$0.00. Authorized capital stock may be paid for in cash, services, or property, at a just value to be fixed by the Board of Directors, of this corporation at any regular or special meeting.

#### **ARTICLE IV.**

The amount of capital with which this corporation shall begin business is ONE THOUSAND (\$1000.00) DOLLARS.

#### **ARTICLE V.**

This corporation shall have perpetual existence.

#### **ARTICLE VI.**

The initial street address of the principal office of this corporation is to be 153 Key Haven Road, Key West, Florida 33040. The Board of Directors may from time to time designate such other post office address and place for the principal office.

#### **ARTICLE VII.**

This corporation shall have three directors initially. The number of directors may be increased from time to time by the by-laws but shall never be less than one. The name and address of the initial directors of this corporation are:

Every amendment shall be approved by the Board of Directors, proposed by him to the stockholders, and approved at a stockholders meeting by a majority of the stock entitled to vote thereon, unless all of the directors and all the stockholders sign a written statement manifesting their intention, that a certain amendment of these Articles of Incorporation be made.

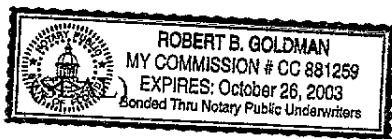

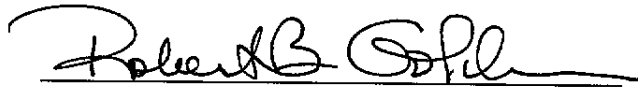

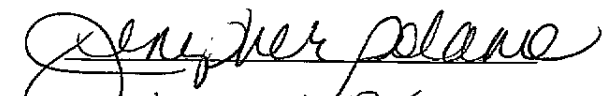
