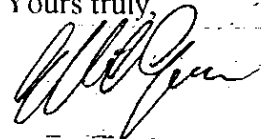
We write with reference to the above matter and note with some concern that this company has been administrative dissolved for non-filing of the 2002 Uniform Business Report.
