

The undersigned, acting as Incorporator for a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

1. The name of the corporation is as follow:

2. The period of its duration shall be perpetual.
3. The purpose is to engage in the transportation service industry and any activities or business permitted under the laws of the United States and the State of Florida.

All of the stock shall be payable in cash or other property, real or personal, tangible or intangible, or in labor or services actually performed for the corporation in lieu of cash at a just valuation to be fixed by the Board of Directors of this corporation.




