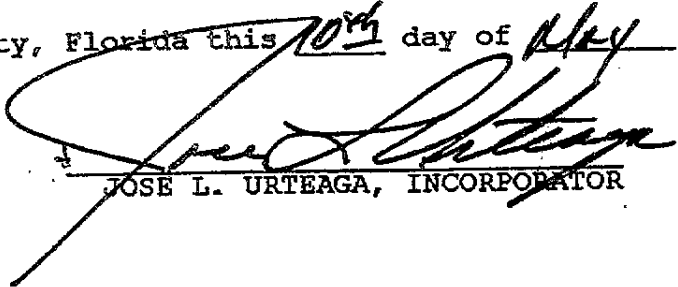
AMENDMENTS

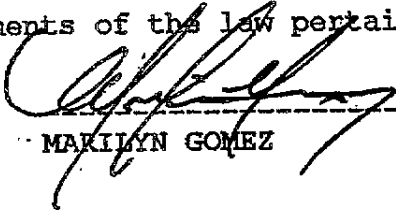
